

Privacy Policy

What information do we collect?

We collect information from you when you register on our site or subscribe to various communications and services that we offer.

When ordering or registering on our site, as appropriate, you may also be asked to enter your name, address, pertinent payment information and your e-mail address.

What do we use your information for?

Any of the information we collect from you may be used in one of the following ways:

To cater our website and app services to provide users with the best service we can:

We continually strive to improve our website offerings based on the information and feedback we receive from you.

To process transactions:

Your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your consent, other than for the express purpose of delivering the purchased product or service requested.

To send appropriate communications:

The email address you provide for order processing, may be used to send you information and updates pertaining to your order, in addition to receiving occasional company news, updates, related product or service information, etc.

Note: Users are always given the opportunity to unsubscribe from communications and we include detailed unsubscribe instructions.

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

We employ third party agents to develop, host and manage our technology via a dedicated and secure web server. They have access to information only needed to perform their functions and are required not to use it for any other purposes. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway provider's database only to be accessible by those authorized with special access rights to such systems, and are required to keep the information confidential.

After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers. Rather all personal financial information is stored via third party integration to comply with Payment Card Industry Data Security Standards (PCI DSS)

How do we use cookies?

Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser, if you allow them, that enable the sites or service provider's systems to recognize your browser and capture and remember certain information. Without Cookies, you will not be able to log in. Cookies also allow information to be retained between visits.

Do we disclose any information to outside parties?

We do not sell, trade, or otherwise transfer your personally identifiable information to outside parties. We do share your information with trusted partners who assist us in operating our website, conducting our business, or servicing you, so long as those parties equally agree to keep this information confidential and, under contractual obligation, comply with our policy of not selling, trading or transferring your personal information. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or other's rights, property, or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

California Online Privacy Protection Act Compliance

Because we value your privacy we have taken the necessary precautions to be in compliance with the California Online Privacy Protection Act. We therefore will not distribute your personal information to outside parties without your consent.
